### **6<sup>th</sup> Grade Presentation (Michelle Hodges)**

- Transition from elementary to middle school
  - o Information disseminated differently
    - Students have done an excellent job adjusting to and navigating new technology
  - o All 488 6<sup>th</sup> graders have learned to use a lock
  - Science
    - Students are enjoying the hands on labs
    - Introducing STEM activities to students
  - World History
    - Flipped learning classrooms
      - Students get notes at home and in-class time is used for hands-on activities
      - Once a unit all World History teachers do a co-teach activity together
        - "Thinking Like a Historian" Filled bags with "trash" and students had to infer what this person was like/what their life was like
    - Guest speakers for PAWS activity
  - Animal Kingdom Field Trip
    - Next Thursday, March 15, 2018
    - o 263 going on the trip

#### Testing

- Mr. Willets requests that the agenda be changed
- Testing will be tabled until April, will be replaced by School Safety talk today
- SAC Members Vote
  - Let the minutes show SAC members approve of this agenda change

#### School Safety (Mr. Willets)

- 2 years ago PBMS had a 2 hour lockdown due to police activity in the area
- St. Johns County schools mandate very specific drills (lockdown, tornado, etc.)
  - Most recent scheduled lockdown drill was the day before the Parkland shooting
- Very clear protocol and action plan on how to deal with any type of threat per St. Johns County Sheriff's Office
  - o PBMS Facility can be locked down in 15 seconds
- Mr. Willets would like community members to think of the follow question while he gives his
  presentation (to be revisited at the end of his talk): "What would make you or your child feel
  safer on campus?"

- PBMS had two social media events
  - One post issued on Wednesday night
  - One post issued on Friday night
- Mr. Willets ask our students to screenshot any concerning social media post and bring it to an adult
  - Typically a 'handle' is attached to the post identifying the user
- Post that happened on Wednesday
  - Occurred later on in the evening
  - Student saw the post on Snapchat, screenshotted post, and showed a parent
  - o Parent contacted the St. Johns County Sheriff's Office
  - o SJCSO contacted J. Willets
  - SJCSO conducted a home visit to investigate the post
    - The post was determined to be false on Thursday morning: The student who posted the Snapchat made-up information about another student
  - This post fueled student and community concern
- PBMS is 1 of 12 schools dealing with this type of situation in the district
- A second false post was sent out on Friday afternoon
  - o J. Willets was contacted by the SJCSO who had been contacted by students and parents
  - Same protocol used as before
  - SJCSO investigated the post
    - The post was determined to be false: Identified to be fabricated information
- It is difficult to deal with these types of situations on a community level because the school is not allowed to give out certain information per the SJCSO investigation
- Increased presence of SJCS Officers on campus to ensure schools and staff felt safe on campus
- Students were notified via all-call during that schooldays that these posts were falsified
- Mr. Willets will delay communicating any information until he ensures the safety of all students
   first call is to law enforcement
- Student Council will be creating PSA's to show students how social media should be used and what should be done if people are not using it correctly
- What is PBMS doing?
  - PBMS does have a fence that completely surrounds the school
  - Drills are practiced monthly
  - o Mr. Willets receives training from SJCSO on active shooter drills
  - Teachers practice drills as well
  - Interior doors can be secured via mag-locks
  - Cameras are all around campus
  - Doors have to be locked from the outside
    - Mr. Blocker is currently working on installing pull-pins on all doors on campus so that doors can be locked from the inside
  - Every classroom has a 2-way message communication system to the office
  - o 15-20 staff members are in constant communication via radio on a closed channel
  - o Processes in place to allow for immediate notification to SJCO
  - Exterior doors on campus
    - Students reminded not to open the door for anyone
  - If students see something they are concerned about they need to tell the closest adult immediately
  - Morning Procedures

# Pacetti Bay Middle School SAC Meeting

- Once the tardy bell rings all doors other than the front office doors are locked
- Upgrades
  - Front door entry being installed, buzz-in entry
    - Security system upgrade
  - Several doors in the front office being redone
    - Will need a swipe card or keycode to access
  - Electronic locking mechanisms on the back doors leading to the portables
    - Students will have to use a code to enter and exit
  - Being able to lock things remotely on timers
  - Integrating all electronic systems into one
  - No plans for metal detectors
- Mr. Willets goal is to be able to secure the school as fast as possible and make it as difficult as
  possible to move throughout the school
- A National Walkout is scheduled for next week
  - Mr. Willets looking into structured activities to allow students to express themselves in a safe manner
