- 1. Welcome, Mr Manias opened the meeting at 2:17
- 2. Financial update- Mr Laga presented the correct funds for SAC at the current time. We noticed items were paid out for the prior approvals
- 3. Karin Gowens requested funds from the committee to purchase a book cover repair machine. Currently the books that are damaged are repaired in house with short term success. The machine can complete the process faster and with long lasting results. Ms. Gowens believed the machine would pay for itself in a single school year. The cost is \$1374. Current staff members have been through the training at PBMS. The cost was proposed to be Between \$2400.00 and \$3000.00. A motion was made and seconded and the motion was carried.
- 5. Volunteers for the school district book objection committee: Ms. Murphy explained the district desires to enlist 24 parents-county wide to respond to books that may be labeled objectionable by other students' parents. Currently, most issues are handled at the school level, such as offering an alternative assignment to a student whose parents object to a particular book. The creation of the committee would be available in lieu of a county wide objection to the content in a particular book. This committee would decide the validity of the book's objection.
