RSV (Returning Student Verification):

The RSV must be completed in order for your student to have a schedule on the first day of school. Every summer, the School District requires parents to complete the returning student verification (RSV) form online. Parents must complete the returning student verification for each child separately. Parents should have received an email from: noreplyregistration@powerschool.com. This will be sent to you every two weeks until it is completed. This must be completed so families may view their student’s middle school schedule on 7/24/25. **If you did not meet this deadline, you still have time to complete the RSV and view your student’s schedule on 8/7/25.**

Rising 6th Graders:

Updated proof of residency must be provided, and the Returning Student Verification (RSV) completed for your student to have a schedule on the first day of school. When you complete the RSV online you can upload proof of residency at the same time. New students to St. Johns County will upload proof of residency when registering.

Rising 7th Graders:

7th grade students are required to have a Tdap and updated FL680 immunization form on file. Students will not receive a schedule until records are received. Bus Information

In May 2025, St. Johns County School District introduced **BusPlanner**, a new online transportation portal designed to give parents easy access to their students’ bus information. Parents can access BusPlanner through its web portal at <https://sjcsd.mybusplanner.com> or by downloading the companion mobile app, **Chipmunk**, available for Android and Apple devices. BusPlanner will also enhance communication by providing timely updates about bus delays and other important transportation-related notifications. In addition, parents can use the system to send

messages directly to the SJCS D Transportation Department. To get started, families should create an account on the [BusPlanner website](#) or on the [Chipmunk app](#) using the **same email address** associated with their Home Access Center (HAC) account. SJCS D encourages all families with bus riders to register early and stay informed ahead of the upcoming school year. View [instructions showing how to create your BusPlanner / Chipmunk account](#).

Ordering Gym Uniforms:

Gym uniforms are available through SchoolPay. Once ordered through School Pay, they can be picked up at the gym during Meet the Teacher August 8th. Gym clothes purchased on or after [Aug 7th](#) through School Pay will be delivered to the students through their PE class.

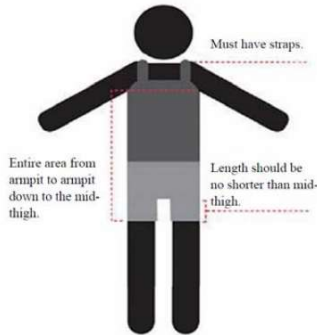


Student Dress Code:

Family/Visitor Access to the School:

Highly Recommended: If you would like access to the school beyond the front office waiting room to conference with the teacher, dean, administration, volunteer at school events, and/or attend a field trip, you must have completed the School Access Form. The approval is good for three years. This is a district policy and there are no exceptions. We do not want to turn families away. Please visit the following link

Clinic & Health Information:

If your student will be carrying non-prescription medication, the following form must be filled out [Self-Administer Over the Counter Form](#) and provided to our nurse. If your student needs or may need prescription medication, the following form must be filled out and signed by a physician. [Prescription Medication Authorization](#). The prescription medication must be handed to our nurse by a parent. Nurse Lewis will be available during "Meet The Teacher" Aug 8th 12:30-3:30pm at the ticket booth by the gym.

Food items to share with other students (ie: b-day cake, cupcakes, box of donuts, etc..) are not accepted due to student allergies and classroom/cafeteria disruption. If the classroom is having an event, the teacher will organize it and send out an approved list of items. Thank you for your understanding.

Transportation:

Students may walk, bike, or dropped off using our car line. Students who live outside of the 2-mile range will be assigned a bus. Bikes should be locked, and students are asked to wear a helmet. If dropping off students, families must use the car line. Students cannot be dropped off in the parking lot. While in car line, students can begin to exit their cars as soon as the side walk begins where you see the bike rack. Students must finish breakfast items or

drinks (ie Starbucks, Dunkin' etc..) before exiting their vehicle in car line. Morning car line opens at 6:55am. We highly encourage families to arrive early to avoid student tardies.

Schoology:

Through Schoology, students will be able to access assignments, textbooks, and communicate with teachers. All students will have log-in information. Families are urged to sign up as well. Parent Access Codes can be found in HAC under "registration". Through Schoology, students and families may communicate with teachers and keep informed. [Schoology](#)

Student Cell Phones, AirPods, Headphones, etc..

Once students enter the building, cell phone use is not permitted until the dismissal bell. This includes all wireless devices (AirPods, headphones, etc..). Students are instructed to leave their cell phones and all wireless devices in lockers, backpacks, or home. Cell phones are not permitted in pockets. If families have a dismissal change or emergency, we deliver these messages immediately to the students.

In accordance with House Bill 1105, the use of wireless communication devices by elementary and middle school students is strictly prohibited during the school day.
